the undersigned, acting as incorporator of a Corporation pursuant to Chapter 617, Florida Statutes adopts the following Articles of Incorporation of such Corporation.

ARTICLE I

The name of the Corporation shall be:

ARTICLE II

The principle place of business shall be 4101 S.W. 27th Street
Hollywood, Florida, 33023 U.S.A.

ARTICLE III

The period of the duration of this Corporation is perpetual unless dissolved according to law.

ARTICLE IV

This Corporation, The Arthur-Bryant Cooperative of 1885, Inc shall be devoted to and shall provide charitable and benevolent assistance for the education, arts, entertainment, scientific, social, medical, worship, professional, historical, patriotic, research and development, patents and all other causes and representations applicable to corporations by-laws. As well as all other societies or organizations permitted under law and rules of court created for self-determination.

ARTICLE V

The qualifications for members and the manner of their admission shall be described in the Corporations By-Laws.

ARTICLE VII

The Corporation is organized under not for profit and a non-stock basis.

In the event of dissolution, the residual assets of the organization will be turned over to one or more organizations which themselves are exempt as organizations described in Section 501(c) and 170(c)(2) of the Internal Revenue Code or the Federal, State or local government for exclusive public purpose.
