ARTICLES OF INCORPORATION

ARTICLE I NAME

The name of the corporation shall be: Historic Quincy Main Street, Inc.

ARTICLE II PRINCIPAL OFFICE

The principal place of business and mailing address of this corporation shall be:

ARTICLE III PURPOSE

The purpose for which the corporation is organized is to stimulate downtown economic development in Quincy, Florida, in a nine block area including the corner of Monroe Street and Crawford Street to the corner of Crawford Street and Duval Street to the corner to Duval Street and Franklin Street and to the corner of Franklin Street to Monroe Street. Stimulation of economic development will be implemented through organization (encouraging cooperation and building leadership in the business community); promotion (creating a positive image of downtown by promoting downtown as an exciting place to live, shop and invest); design (improving the appearance of downtown); and to receive, administer and distribute funds in connection with any activities related to the above purposes; provided however, that the Program shall only engage in activities that are in the purview of Section 501 (c)(3) of the Internal Revenue Code of 1954, as now or hereafter amended. In order to effectuate such intent, no part of the net earnings of the Program shall inure to the benefit of any of its members or any other individual; and the Program shall not participate in, or intervene in, any political campaign on behalf of any candidate for public office.

ARTICLE IV MANNER OF ELECTION:

The manner in which the directors are elected or appointed: An election was held on May 13, 2002. Each person had to be nominated, seconded and have majority consensus.


