ARTICLES OF INCORPORATION

OF

(NON-PROFIT)

The undersigned, acting as incorporators of a corporation pursuant to Chapter 617,
Florida Statutes, adopt the following Articles of Incorporation

ARTICLE I
CORPORATE NAME

CORPORATE NATURE

This is a non-profit organization organized exclusively for religious, charitable, or educational purposes within the meaning of section 501 (c) (3) of the Internal Revenue Code. Notwithstanding any other provision of these Articles, the organization shall not carry on any other activities not permitted to be carried on by an organization exempt from federal income taxes as an organization described in section 501 (c) (3) of the Internal Revenue Code, (or corresponding section of any future federal tax code).

**ARTICLE IV
MANNER OF ELECTION OF OFFICERS**

The manner in which the Officers are elected or appointed is as follows:

This corporation should be organized and operated exclusively for the purposes specified in section 501 (c) (3) of the Internal Revenue Code and which has established its tax-exempt status under that section.
