ARTICLES OF INCORPORATION

In compliance with Chapter 617, F.S., (Not for Profit)

The undersigned natural person of the age of twenty-one years or more, acting as incorporator, adopts the following Articles of Incorporation pursuant to the Florida Chapter 617, F.S. (Not for Profit)

Article I NAME

The name of the corporation shall be Seabreeze Elementary P.T.O., Inc.

Article II PRINCIPAL OFFICE

The principal place of business and Mailing address of this corporation shall be 1400 Seabreeze Avenue, Jacksonville Beach, FL 32250, Duval County

Article III PURPOSE

The corporation is organized and will be operated exclusively for charitable and educational purposes within the meaning of 501(c)(3) of the Internal Revenue Code. (All references to sections in these Articles refer to the Internal Revenue Code of 1986 as amended or to comparable sections of subsequent internal revenue laws.) In pursuance of these purposes it shall have the powers to carry on any business or other activity which may be lawfully conducted by a corporation organized under the Florida Nonstock Corporations Act, whether or not related to the foregoing purposes, and to do all things necessary, proper and consistent with maintaining tax exempt status under section 501(c)(3).

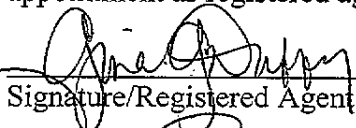

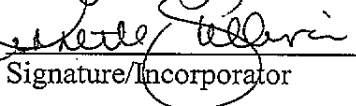
