**ARTICLE I:**

The name of corporation shall be Heavenly Outreach Center Inc.  
This corporation is organized pursuant of the FLORIDA NON-PROFIT Corporation Codes.

**ARTICLE II:**

The principal place of business of this corporation Shall be 252 w Blue Heron Bld. # 2 Riviera Beach, FL 33407. The mailing address of this Corporation shall be P.O. Box 10712 Riviera Beach FL 33419 in Palm Beach County

**ARTICLE III:**

The specific purpose(s) for which the corporation is organized for transacting any and all lawful business for which corporations may be incorporated under FLORIDA Nonprofit Corporation Act and to distribute the whole or any part of the income there from and the principal thereof exclusively for charity, Religious, scientific, literary or educational purposes, either directly or by contribution to organizations that qualify as exempt organizations under Section 501© (3) of the Internal Revenue Code and Regulations issued pursuant thereto, as they now exist or as they may here after be amended. The corporation's programs will consist of, but not limited to, Child Development Services; Outreach Programs; Teenage Pregnancy & HIV/AIDS Prevention; Literacy Programs; Temporary Shelter; Job Training; Job Placement; Tutoring; Family Counseling; Housing; Community Services; Medical Services; Substance Abuse Awareness and Prevention Computer Training and other programs to aid those in need and will focus on a life of self-sufficiency.



**ARTICLE IV:**

The manner in which the directors are elected or appointed is as follows: The affairs of the Corporation shall be governed by a Board of Directors (hereinafter referred to as the Board) elected in accordance with the Bylaws, subject to the restriction that, except as specifically set forth to the contrary in the Bylaws, the exercise of any power or actions of the Board shall require the approval thereof by a majority vote of the Board present at a meeting at which a quorum of no less than two (2) Directors shall necessary for all corporate action requiring a vote of the Board.

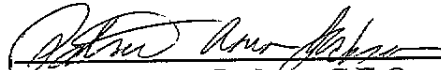

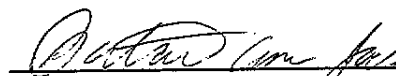

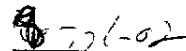
