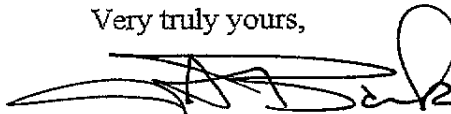

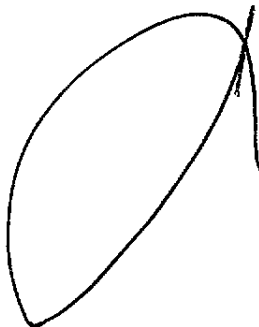

ARTICLES OF INCORPORATION
OF
SCHOOL SUPPLIES FOR AFGHANISTAN, INC.

The undersigned subscribers to these Articles of Incorporation, natural persons competent to contract, hereby associates themselves together to form a corporation not for profit under the laws of the State of Florida.

ARTICLE I. NAME

The name of the corporation is: SCHOOL SUPPLIES FOR AFGHANISTAN, INC.

ARTICLE II. PURPOSE

The purpose of this corporation is the delivery of school supplies to the children of Afghanistan and the funding of as many teaching positions throughout Afghanistan as finances will permit.

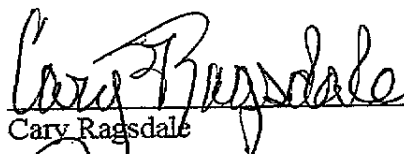
ARTICLE IX. AMENDMENT

ARTICLE X. DESIGNATED RESIDENT AGENT

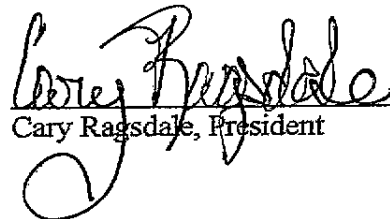

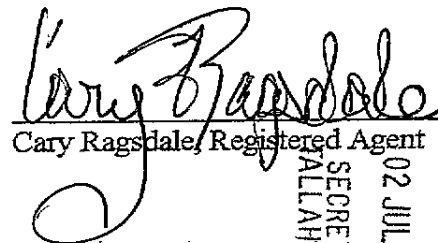
