ARTICLE I
NAME

The name of the corporation shall be North Florida Christian Bass Club, Inc., a Florida non-for-profit corporation.

ARTICLE II
PRINCIPAL OFFICE

The principal office of the corporation shall be at 7776 Morse Avenue, Jacksonville, Florida 32244

ARTICLE III
PURPOSE

The club is founded on the idea of Christian fellowship used as a tool for Christian outreach and help other Christian outreach ministries. And also is to make a spiritual impact in the lives of fellow fisherman to follow Christ as our own, and to help are community while furthering our skills in bass fishing.

ARTICLE IV

MANNER OF ELECTION

- A. Term limits for all directors/officers will be twenty-four months. Starting and ending after the Classic Tournament in October. If elected, an officer can have consecutive terms.
- B. Any director/officer (if nominated) may run for another position if available regardless of time served.
- C. The club reserves the right to move any director/officer time with a 2/3-majority vote from the club.
- D. Nomination of directors/officers will be taken all position available at the September meeting. You must be present to make a nomination.
- E. Nominees must be at least 18 years of age, full member and show an interest in the business at the October meeting will hold an election for directors/officers.
- F. In the event an office becomes vacant, an emergency election will be held to fill the vacant position at the next meeting.

ARTICLE V
DIRECTORS/OFFICERS

The Officers of the corporation shall be those indicated in the bylaws. Notwithstanding anything contained in the bylaws to the contrary, there shall be a President, Vice President, Secretary, Treasurer, Chaplin, and Club Merchandiser of the Corporation. 
