**Article 3
Purpose & Policies**

Purpose

Section 1. THE PEACE INSTITUTE is organized exclusively for Educational, religious,
charitable, and social purposes, including the making of contributions to
organizations that qualify as exempt organizations under Section 501 (c) (3) of the
Internal Revenue Code of 1954, or any future corresponding code of U.S. Internal
Revenue Law.

Services

Section 2. THE PEACE INSTITUTE shall provide educational, religious, charitable, and social
services to educational institutions (schools, colleges, universities, etc.) both private
and public, to corporations and businesses, to religious institutions, to civic and
community organizations, to government, and to the general public.

Policies

Section 3. THE PEACE INSTITUTE's policies are based on the bylaws made by the Board of

The effective date of incorporation shall be August 1st, 2002.


