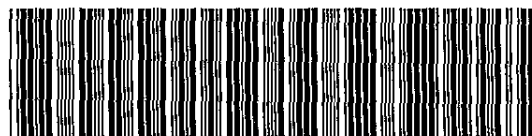



**ARTICLE IV
GENERAL AND SPECIFIC PURPOSES**

Section I – General Purpose

The mission of Home of Angels is to meet the needs of the communities through unity, in order to *improve the economic*, educational and social welfare of residents and to preserve the cultural heritage of our communities.

Section II – Internal Revenue Service

Notwithstanding any other provision of these articles, this organization shall not carry on any activities not permitted to be carried on by an organization exempt from federal income tax under section 501(c) (3) of the Internal Revenue Law.

For charitable Christian education and scientific purposes, including for such purposes, the making of distribution to organizations that qualify as exempt organizations under section 501(c) (3) of the Internal Revenue Code of 1954 or the corresponding provision of any future United States Revenue Law.
