ARTICLES OF INCORPORATION

LONG TERM ASSISTANCE PROGRAM, INC.

ARTICLE ONE

The name of the corporation is Long Term Assistance Program, Inc.

ARTICLE TWO

The principal place of business of this corporation shall be: P.O. Box 5406, Spring Hill, FL 34611.

The period of the duration of this corporation is perpetual unless dissolved according to law.

ARTICLE THREE

The specific purpose for which the corporation is organized are:

- 1. To demonstrate our compassion by responding to basic physical and emotional needs.
- 2. To raise the resources of volunteer help, prayer support money, in kind gifts, and long-term follow-up from churches and community.
- 3. To provide funds for medical, dental, Rx, housing, transportation and miscellaneous needs, for an extended period of time.
- 4. To do all other matters and things whatsoever necessary, convenient, useful or incidental to the carrying out of the purposes of the Corporation.

ARTICLE FOUR

The membership of this corporation shall be open to all persons who: are unselfishly willing to work and deal with the needy of the community by volunteering their time, skills and energy. No officer or member shall for reason of his office or membership be entitled

to receive any salary or compensation, but nothing herein shall be construed to prevent an officer or member from receiving any compensation from the corporation for duties other than as an officer or member. The initial Board of Directors has been appointed by the Incorporators as shown in Article VII.

The number constituting the initial Board of Directors of the corporation is three (3), and the names and addresses of the persons who are to serve initially are:

The initial Board of Directors will appoint additional Directors as required by the By-Laws of the corporation.

ARTICLE FIVE

The corporation is organized under a non-stock basis, but no other limitations of corporate powers as authorized under section 617.0302 will be binding.

Membership in the corporation may be terminated by submission of written resignation. There will be no benefits or residual benefits to a terminated member, and membership is not transferable.

Upon the dissolution of the corporation, assets shall be distributed for one or more exempt purposes within the meaning of section 501 (c) (3) of the Internal Revenue Code, or corresponding section of any future federal tax code, or shall be distributed to the federal government, or a state or local government, for the public purpose. Any such assets not so disposed of shall be disposed of by the Court of Common.

Pleas of the county in which the principal office of the corporation is then located, exclusively; for such purposes or to such organization or organizations, as said Court shall determine, which are organized and operated exclusively for such purpose.

There shall only be one class of member to this corporation, and this class shall be non-voting members.

Membership will be open upon the incorporation of this non-profit corporation.

This corporation will be a separate and distinct corporation, not subject to the authority of any national associations.

The purpose for which the corporation is organized is exclusively

charitable within the meaning of section 501 (c) (3) of the _____ Internal Revenue Code of 1996 the corresponding provision of any future United Stated Internal Revenue Law.

Notwithstanding any other provisions of these articles, this organization shall not carry on any activities not permitted to be carried on by an organization exempt form Federal income tax under section 501 (c) (3) of the Internal Revenue Code of 1986 or the corresponding provision of any future United States Internal Revenue Law.
