

Articles of Incorporation In Compliance with Chapter 617, F.S., (Not for Profit)

Article I Name

The name of the corporation shall be: Central Florida Code Enforcement Association, Inc.

Article II <u>Principal Office</u>

The principal place of business and mailing address of this corporation shall be: 401 Park Avenue South, Winter Park, FL 32789

Article III Purpose

The purpose for which the corporation is organized is:

- To increase Central Florida networking and coordination efforts among fellow professionals.
- To aggressively attack problem cases, ordinances, and personnel issues we deal with daily. В.
- To create standard educational tools that would be beneficial to Central Florida citizens. C. D.
- To assist the Florida Association of Code Enforcement (FACE) with their goals; commit to publishing an article in the Interface newsletters.
- E. To be a working organization creating solutions.
- To improve service and quality of life for citizens within the Central Florida. F.
- To improve the prestige of Code Enforcement Officials by the promotion of higher standards of education G. and efficiency in the administration and application of environmental laws.

Manner of Election Article IV

The manner in which the directors are elected or appointed:

- Regular elections shall be held at the April meeting as terms expire. Α. В.
- The President will appoint a nominating committee consisting of three or more persons who are Active Members in good standing of the association. This appointment shall be done at least 60 days prior to the scheduled election.
- C. The nominating committee shall prepare a slate of nominees for the offices of the President, Vice President, Secretary, Treasurer, and Sergeant at Arms.
- The nominating committee may select and recommend more than one person for all offices, not to exceed D. three persons per office.
- In the event there is only on nominee for any particular office, the membership assembled may instruct the E. Secretary by proper action to cast a ballot for the full number of qualified voters at the meeting for the said nominee whereupon the President shall declare him/her elected by association.
- The President will ask the floor for any late nominations. F.
- Only voting delegates or alternates may cast ballots for election of Officers. G.
- Η. There shall be no proxy ballots.
- The President shall announce the results of all balloting and shall declare all elections. In order to be I. elected, a candidate must receive the most votes cast. J.
- Voting will be by written secret ballot under such rules and at such times as may be established by the Board of Officers.
- Formal notification of the election results shall be prepared by the Secretary and mailed to each CFCEA K. Member.
- Officers shall be installed immediately following their election.
