**ARTICLES OF INCORPORATION  
OF

THE UNDERSIGNED, acting as incorporator of a Corporation Not for Profit under the Florida Not For Profit Act, Chapter 617, Florida Statutes, adopts the following Articles of Incorporation for such corporation:

**ARTICLE I**

The name of this corporation is DISABLED ISRAELI VETERANS HOST PROGRAM OF SOUTH FLORIDA, INC.

**ARTICLE II**

The principal office of business and mailing address of this Corporation shall be: c/o Rivka Sadja, 5118 N.W. 24th Way, Boca Raton, Florida 33496.

**ARTICLE III**

The purpose or purposes for which this corporation is organized are:

A. To conduct activities which are exclusively charitable, cultural and educational within the meaning of the Chapter 617, Florida Statutes and Section 501(c)(3) of the Internal Revenue Code of 1986, as the same may be amended from time to time, including, without limitation, the advancement of the recovery of Israel War Disabled persons through a program of rest, cultural and educational enrichment of their knowledge of this country and state, and the conduct of any and all other activities as shall from time to time be found appropriate in connection with the foregoing and as are lawful for a Corporation under the Florida Not For Profit Corporation Act.

No Part of the activities of the corporation shall be devoted to carrying on propaganda, or otherwise attempting to influence legislation, and the corporation shall not participate in or intervene (including the publishing or distributing of statements) in any political campaign on behalf of any candidate for public office.

This Corporation is not formed for pecuniary profit or financial gain and no part of its assets, income or profit shall be distributed to or inure to the benefit of any private individual.

B. This Corporation shall be authorized to engage in or include among its purposes any of the purposes mentioned in the Internal Revenue Code and the Florida Not-For-Profit Corporation Act.

C. To do each and every thing necessary, suitable or proper for the accomplishment of any of the purposes or the attainment of any one or more of the subjects herein enumerated, or which may at any time appear conducive to or expedient for the protection or benefit of this corporation, and to do said acts as fully and to the same extent as natural persons might, or could do, in any part of the world as principals, agents, partners, trustees or otherwise, either alone or in conjunction with any other person, association or corporation.

D. The foregoing clauses shall be construed both as purposes and powers, and shall not be held to limit or restrict in any manner the general powers of the corporation, and the enjoyment and exercise thereof, as conferred by the Laws of the State of Florida; and it is the intention that the purposes and powers specified in each of the paragraphs of this Article III shall be regarded as independent purposes and powers.

#### **ARTICLE IV - MANNER OF ELECTION**

The number of directors of the Corporation from time to time shall be as set forth in the By-Laws. The number of directors constituting the initial Board of Directors of this Corporation is four (4). Directors of the Corporation shall serve until the first annual meeting of shareholders, or until their successors are elected and qualify.
