

## ARTICLES OF INCORPORATION

The undersigned incorporator, for the purpose of forming a corporation under the Florida Not for Profit Corporation Act, hereby adopt(s) the following Articles of Incorporation:

### ARTICLE I NAME

The name of the corporation shall be: Clay County Friends of Youth, Inc.

### ARTICLE II PRINCIPAL OFFICE

### ARTICLE III PURPOSE(S)

The specific purpose(s) for which the corporation is organized is (are):

To assist in the enhancement of Youth Activities in Clay County, Florida pursuant to the provisions of 501(c)(3) of the IRC, and the corresponding provision of any future US/IRS law thereto and such purposes shall include, but not be limited to the following:

Providing financial assistance for wholesome activities and recognition to the youth and their leaders.
