# Articles of Incorporation Of Miami-Dade County Voluntary Organizations Active in Disasters. Inc.

A Not-for-Profit Corporation

We the undersigned, natural persons competent to contract, do hereby make, subscribe, and file these Articles of Incorporation for the purpose of organizing a corporation not-for-profit under Chapter 617 of the State of Florida.

#### **ARTICLE I - NAME**

The name of this corporation shall be MIAMI-DADE COUNTY VOLUNTARY ORGANIZATIONS ACTIVE IN DISASTERS, INC.

### ARTICLE II - PRINCIPAL PLACE OF BUSINESS

#### ARTICLE III - PURPOSE

This corporation is organized and committed to the purpose of building a solid foundation for disaster response and recovery for the residents of Miami-Dade County, Florida.

#### <u>ARTICLE IV – ELECTION OF DIRECTORS</u>

The affairs and business of the corporation shall be conducted by a Board of Directors consisting of the number of directors determined by the bylaws of the corporation, but this number shall not be less than three (3) nor more than nine (9) directors. The directors shall be elected at the annual meeting provided for in the bylaws of the corporation.
