ARTICLES OF INCORPORATION
OF
THE REBORN APOSTOLIC MINISTRIES INTERNATIONAL, INC.

ARTICLE I. CORPORATE NAME

The name of this corporation is THE REBORN APOSTOLIC MINISTRIES INTERNATIONAL, INC.

ARTICLE II. PRINCIPAL OFFICE

The principal place of business and mailing address of this corporation is 826 Peachtree Street, Cocoa, FL 32922.

ARTICLE III. PURPOSE OF CORPORATION

The purpose for which this corporation is organized is to promote the teaching of the Lord, and good will to all mankind. To establish and maintain a place of worship. To unite a people of like faith in the bonds of brotherly love and fellowship. To meet together to worship God in Spirit and truth. To point the lost to the way of life by publishing at home and abroad the true plan of salvation. To provide Christian rules of conduct. Based upon the Bible. To foster an appreciation and love for God through lectures, seminars, study groups, exhibits, conferences, camp meetings, the printed page and any and all other appropriate means. All monies collected are to be used to cover overhead expenses and the balance to be dispersed among the needy.

ARTICLE IV. BOARD OF DIRECTORS

ARTICLE V. CORPORATE POWERS

The Corporate Powers shall not be limited. This Corporation shall have full exercise of all powers necessary to carry out the purpose and objectives of this corporation, as may be determined by the Board of Directors, in accordance with Section 617.0302, Florida Statutes.

The Board of Directors is empowered to make, alter, or repeal the Bylaws of the corporation without restriction of their powers conferred by statute.

ARTICLE VI. DURATION OF CORPORATION

The period of the duration of this corporation shall be perpetual.

ARTICLE VII. DISSOLUTION OF CORPORATION

Upon the dissolution of this corporation, its assets and remaining after payment or provision for payment, of all debts and liabilities of this corporation shall be distributed for one or more exempt purposes within the meaning of Section 501 (C) (3) of the Internal Revenue Code.
