**ARTICLES OF INCORPORATION**

**ARTICLE I**  
**NAME**

The name of the corporation shall be CHURCH OF THE HOLY CROSS & HOLY SPIRIT (CEEC), INC.

**ARTICLE II**  
**PRINCIPAL PLACE OF BUSINESS**

The principal place of business address of the corporation will be 608 NE 48<sup>th</sup> Avenue, Ocala, Florida 34470. The mailing address is Post Office Box 236, Ocala, Florida 34478.

**ARTICLE III**  
**PURPOSE**

The purpose of the corporation is to preach the gospel of Jesus Christ, to evangelize in order to bring people to God, and to conduct outreach ministries to help people in need; the corporation shall have the power to lease and own real and personal property for uses appropriate to furthering the foregoing purposes.

**ARTICLE IV**  
**APPOINTMENT OF DIRECTORS**

The corporation will have six Directors who shall be appointed by the members and the President in the manner set forth in the By-Laws.

**ARTICLE V**  
**INITIAL REGISTERED AGENT AND STREET ADDRESS**

The name and Florida street address of the registered agent is Charles M. Johnson, 608 NE 48<sup>th</sup> Avenue, Ocala, Florida 34470.

## **ARTICLE VI INCORPORATOR**

The name and address of the incorporator is Charles M. Johnson, 608 NE 48<sup>th</sup> Avenue, Ocala, Florida 34470.

## **ARTICLE VII AUTHORITY**

The corporation will be subordinate to and subject to the authority of The Holy Spirit and the Archbishop of the Province of Saint Peter of the Communion of Evangelical Episcopal Churches.

## **ARTICLE VIII MEMBERSHIP**

The corporation shall have two members; the names of the initial Members of the corporation are set forth below. The Members shall have life terms, and upon termination of membership by death or resignation new Members shall be elected by a majority of the Directors. The Members, together with the President, will appoint the Directors in the manner set forth in the By-Laws. The initial life Members of the corporation are:

## **ARTICLE IX AMENDMENT**

This corporation may amend its certificate of incorporation in any respect, provided that only such provisions shall be inserted by amendment as would be lawful and proper in an original certificate of incorporation made at the time of making such amendment. Every amendment shall be proposed by a Member and approved by a majority of the Members.

## **ARTICLE X NO DISCRIMINATION**

The corporation will be an equal opportunity organization, and there shall be no discrimination in membership or in hiring of employees based on race or national origin.

**ARTICLE XI  
DISSOLUTION**

Upon dissolution of the corporation, all corporate assets shall be transferred and given over to the Province of Saint Peter of the Communion of Evangelical Episcopal Churches.

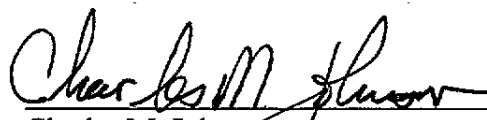
