Amendments to the Articles Of Incorporation:

Articles of incorporation of Federation Of Indian Associations Offee, ELORIDA Tampa Bay, Inc. dated August 12, 2002 shall be amended with the addition of the following two articles:

ARTICLE V111

No part of the net earning or the assets of the association shall insure to to the benefit of or be distributable to its members, trustees, officers, or other private persons, except that the corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purpose set fourth in Article Third hereof. No substantial part of the activities of the corporation shall be the carrying on of propaganda or otherwise attempting to influence legislation, and the corporation shall not participate in, or intervene in (including the publishing or distribution of statements) any political campaign on behalf of or in opposition to any candidate for public office. Notwithstanding any other provision of these articles, the corporation shall not carry on any other activities not permitted to be carried on (a) by a corporation exempt from Federal Income Tax under Section 501 (C) (3) of the Internal Revenue Code or the corresponding section of any future federal tax code, or (b) by a corporation, contribution to which are deductible under section 170 (c) (3) of the Internal Revenue Code or the corresponding section of any future federal tax code.

ARTICLE 1X

Dissolution of the Corporation:

Upon the dissolution of the Corporation, assets shall be distributed for One or more exempt purposes within the meaning of section 501 (c) (3) of the Internal Revenue Code, or the corresponding section of any future federal tax code, or shall be distributed to the federal government, or to a state or local government, or for a public purpose. Any of such assets not so disposed of shall be disposed of by the court of the appropriate jurisdiction of the county in which the principal office of the Corporation is then located, exclusively for such purposes or to such organization or organizations as said court shall determine, which are organized and operated exclusively for such purposes.
