

These Articles of Amendment were adopted by the board of directors of said organization at a regular meeting with a quorum being present which was held on July 28, 2107. This meeting of directors met the requirements of both the Articles of Incorporation and the bylaws.

The Amendments

The Articles of Incorporation of Geraldine Ransome Fields Christian Academy are hereby amended as follows:

1. Article 1 of the Articles of Incorporation is hereby replaced. The new Article 1 reads in its entirety as follows:

Article 1

The name of the corporation is **Living Way Fields of Art Christian Academy, Inc**. This not for profit corporation is organized to provide a quality education in a Christian environment by teaching toward the total development of the student's mind, character, and body for excellent academic performance and an exceeding abundant life.

The Corporation is organized exclusively for charitable, religious, educational and scientific purposes, including for such purposes, the making of distributions to organizations that qualify as an exempt organization under section 501(c)(3) of the Internal Revenue Code, or the corresponding section of future federal tax code.

No substantial part of the activities of the corporation shall consist of the carrying on of propaganda or otherwise attempting to influence legislation, and the corporation shall not participate in, or intervene in, any political campaign on behalf of any candidate for public office.

Notwithstanding any other provision of these articles, the corporation shall not carry on any other activities not permitted to be carried on (a) by a corporation exempt from federal income tax under section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code, or (b) by a corporation, contributions to which are deductible under section 170(c)(2) of the Internal Revenue Code, or the corresponding section of any future federal tax code.
