ARTICLE I: NAME

The name of this organization shall be the National Association for Black Veterans, Jacksonville Chapter, Inc.

ARTICLE II: PRINCIPAL OFFICE

The principal place of business and mailing address of this corporation shall be: 1706 Bartlett Avenue
Orange Park, Florida 32073

ARTICLE III: PURPOSE

The organization shall operate as a Veterans Service Organization under section (501)©(3) of the Internal Revenue Code of 1954, as amended for the following purposes:

To uplift Black Veterans and veterans, intellectually, economically and morally, while promoting unity through community activism; (b) obtain and maintain holistic, legitimate vested rights, entitlements, and privileges of veterans that include health, housing, education, rehabilitation (physical and mental), employment, and economic assistance; (c) to establish and maintain monuments honoring the memory and legacy of Black Veterans, (d) to follow and maintain the policies and principles as set forth in the National Constitution of the National Association for Black Veterans. Priority services are given to address issues of veteran's homelessness, youth employment and community development.

ARTICLE IV: MANNER OF ELECTION

Each Director/Officer shall hold office for a term of three (3) years. Directors/Officers shall be elected by ballot voted by members in good standing with elections to be held the second week of December of the election year. The term of office for Directors/Officers shall begin upon installation at the January meeting following the election. A Director/Officer may be re-elected for a second term of three (3) years. But, no Director/Officer shall be elected after a second three (3) year term without sitting out of office a full term.
