ARTICLES OF INCORPORATION
OF
DAVE THOMPSON GOSPEL MINISTRIES, INC.

I.

The name of the Corporation shall be "DAVE THOMPSON GOSPEL MINISTRIES, INC."

II.

The Corporation shall be organized pursuant to the provisions of the Florida Nonprofit Corporation code, Chapter 617, F.S., (Not for Profit)

III.

The Corporation shall have perpetual duration. The purpose of the Corporation is to proclaim The gospel of Christ through preaching, music recordings and distribution of music for choirs and Organizations.

IV.

The Corporation is a nonprofit religious corporation. The street address of the initial registered office of the corporation is 1309 Valparaiso Blvd., Niceville, Florida 32578 and the initial registered agent for the corporation is David L. Thompson. The principal mailing address of the corporation is 1309 Valparaiso Blvd., Niceville, Florida 32578.

V.

The name of the incorporator is David L. Thompson and the address of the incorporator is 1309 Valparaiso Blvd., Niceville, Florida 32578.

VI.

The corporation will not have members.

VII.

Upon dissolution, after all creditors of the corporation have been paid, its assets shall be distributed to one or more organizations that qualify as exempt organizations under 501 © (3) of the Internal Revenue Code of 1986, or a corresponding section of any future Federal tax code, giving priority to a similar religious organization, or shall be distributed to the Federal Government, or to a state or local government, for exclusively public purposes.

VIII.

To the extent allowed by the laws of the State of Florida, no present or future director of the corporation (or his or her estate, heirs and personal representatives) shall be liable to the corporation for monetary damages for breach of fiduciary duty as a director of the corporation. Any liability of a director (or his or her estate, heirs and personal representatives) shall be further eliminated or limited to the fullest extent allowed by the laws of the State of Florida, as may hereafter be adopted or amended.

IX

With respect to claims or liabilities arising out of service as a director or officer of the corporation, the corporation shall indemnify and advance expenses to each present and future director and officer (and his or her estate, heirs and personal representatives) to the fullest extent allowed by the laws of the State of Florida, both as now in effect and as hereafter adopted or amended.

X


The purpose for which the corporation is organized are: to operate exclusively for charitable and religious purposes within the meaning of Section 501 © (3) of the Internal Revenue Code of 1986, or corresponding section of any future Federal tax code; and generally to engage in any other lawful endeavor or activity in furtherance of any of the foregoing purposes.

XI

No part of the net earnings of the corporation shall inure to the benefit of, or be distributable to, its directors, officers, or other private individuals or persons, except that the corporation shall be authorized and empowered to pay reasonable compensation for goods and services rendered and to make payments in furtherance of the purposes set forth in the paragraph just above. Notwithstanding any other provision of these Articles of Incorporation, the corporation shall not carry on any endeavors or activities not permitted to be carried on by a corporation exempt from Federal income tax under Section 501 © (3) of the Internal Revenue Code of 1986, or corresponding section of any future Federal tax code, or by a corporation, contributions to which are deductible under Section 170 © (2) of the Internal Revenue Code of 1986, or corresponding section of any future Federal tax code.

We are requesting an effective date of July 24, 2002 to begin doing business as a corporation.
