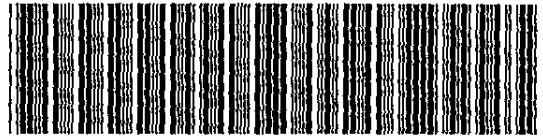

Pursuant to the provisions of section 617.1006, Florida Statutes, this **Florida Not for Profit Corporation** adopts the following amendment to its Articles of Incorporation:

Amendments Adopted:

ARTICLE X. AMENDMENT
ARTICLE of DISSOLUTION

Upon the time of dissolution of the corporation, assets shall be distributed by the Board of Directors, after paying or making provisions for the payment of all debts, obligations, liabilities, costs and expenses of the corporation, for one or more exempt purposes within the meaning of section 501 (c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code, or shall be distributed to the federal government, or to a state or local government, for a public purpose.

Any such assets not so disposed of shall be disposed of by a Court of Competent Jurisdiction of the county in which the principal office of the corporation is then located, exclusively for such purposes or to such organization or organizations, as said Court shall determine, which are organized and operated exclusively for such purposes.

ARTICLE X. AMENDMENT
PURPOSE

Section 1: The object of the association:

- a. To promote the welfare of band students at Barbara Goleman Senior High School in home, school and the community.
- b. To raise the standards of home life through music and related cultural events.
- c. To assist other parent associations and the school community to secure and adequate laws for the care and protection of the students.
- d. To bring into closer relation the home and the school, that parents and teachers cooperate intelligently in the education of the children.
- e. To ensure that each student musician has the same opportunity to participate in each event, regardless to economic, ethnic or cultural differences.

Section 2. The organization is organized exclusively for the charitable, scientific, literary or education purposes within meaning of section 501 (c) (3) of the Internal Revenue Code or corresponding Section of any future Federal tax code.


