These Articles of Incorporation are made pursuant to Chapter 617 Florida Statutes Not
For Profit Corporation. SECRETARY OF STATE
TALLAHASSEE FLORIDA

ARTICLE ONE

1. The name of the Corporation shall be RV Angels Inc., a Florida Not
For Profit Corporation.
