THIS IS TO CERTIFY that we, the undersigned, do hereby associate ourselves into a corporation pursuant to the provisions of the laws of the State of Florida, providing the formation of corporations for not-for-profit, and the purposes and with powers hereinafter mentioned; and to that end, we do by this Certificate set forth:

ARTICLE I

NAME

The name of the corporation shall be Sunraise Fundraising Consultants, Inc., a Florida not-for-profit corporation. The principle office of this corporation is 627 Live Oak Lane, Weston, FL 33327. The mailing address of this corporation is 627 Live Oak Lane, Weston, FL 33327.

ARTICLE II

PURPOSE OF CORPORATION

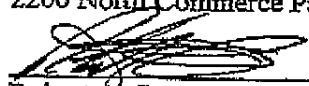
