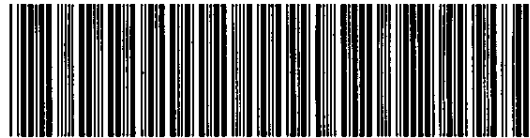

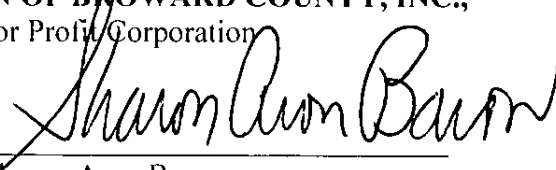
2. That the principal address and mailing address for the Corporation shall be 800 SE Third Avenue, Fourth Floor, Fort Lauderdale, Florida 33316.
