ARTICLES OF INCORPORATION

FOR

SEMINOLE AUDUBON SOCIETY, INC.

EFFECTIVE DATE 2: 03

The undersigned citizens of the United States, desiring to form a not-for-profit corporation under the Florida Not For Profit Corporation Act, Chapter 617, Florida Statutes, certify and acknowledged the following:

ARTICLE I NAME OF CORPORATION

The name of the Corporation Not For Profit shall be **SEMINOLE AUDUBON SOCIETY**, **INC.** (hereinafter referred to as the "Corporation").

ARTICLE II PRINCIPAL OFFICE

The principal office and mailing address of the Corporation shall be Post Office Box 2977, Sanford, Florida 32772-2977.

ARTICLE III TERM OF EXISTENCE

This Corporation shall begin its existence as of the 8th day of August, 2002, and shall exist perpetually.

ARTICLE IV GENERAL PURPOSE

This Corporation is organized and operating for charitable, scientific, and educational purposes within the meaning of Section 501(c)(3) of the Internal Revenue Code of 1986, as may be amended. Specifically, the Corporation is organized to promote awareness and protection of the plants and animals in the St Johns River basin in order to sustain the beneficial coexistence of nature and humans.

ARTICLE V REGISTERED OFFICE AND REGISTERED AGENT

The street_address of the initial Registered Office of the Corporation in the State of Florida will be 1340 Tuskawilla Road, Suite 106, Winter Springs, Florida 32708, and the name of the initial Registered Agent at such address is GRACE ANNE GLAVIN, ESQUIRE.

ARTICLE VI <u>DIRECTORS AND INCORPORATORS</u>

The initial number of directors of this Corporation shall be three (3). The directors of the Corporation shall be elected in accordance with the methods and qualifications specified in the bylaws of the Corporation. In no event, however, shall the number of directors be fewer than three (3).

ARTICLE VII POWERS

The powers of the Corporation shall be provided in the bylaws of the Corporation in accordance with Chapter 617, Florida Statutes with the following limitations within the meaning of §501(c)(3) of the Internal Revenue Code, as may be amended:

- 1. No part of the net earnings of the Corporation shall inure to the benefit of, or be distributed to its members, directors, officers, or other private interests. However, the Corporation shall be authorized and empowered to pay a reasonable flat salary for services rendered by its employees and to make payments and other distributions in furtherance of the purposes set forth in Article IV.
- 2. Only an insubstantial amount of the activities of the Corporation shall be in furtherance of a purpose not set forth in Article IV.
- 3. Only an insubstantial amount of the activities of the Corporation shall be carrying on of propaganda, or otherwise attempting to influence legislation, within the meaning of §501(c)(3) of the Internal Revenue Code, as may be amended, unless the Corporation elects the provisions of §501(h) of the Internal Revenue Code, as may be amended.
- 4. In no event shall the Corporation have the power to participate in, or intervene in, including the publishing or distributing of statements, any political campaign on behalf of, or in

opposition to, any candidate for public office, all within the meaning of §501(c)(3) of the Internal Revenue Code, as may be amended.

5. In the event the Corporation chooses to litigate, using its own staff attorneys on behalf of its members or other clients, the Corporation shall comply with the guidelines provided within Revenue Procedure 92-59, 1992-2 C.B. 411-12, as may be amended, superseded, or modified. The bylaws of the Corporation shall adopt these provisions accordingly.

ARTICLE VIII AMENDMENT TO ARTICLES

The Corporation reserves the right to amend or repeal any provisions contained in these Articles of Incorporation, or any amendment thereto.

ARTICLE IX INDEMNIFICATION

The Corporation shall indemnify any incorporator, officer, director, or any former incorporator, officer, or director, to the full extent permitted by law.

ARTICLE X DISSOLUTION

Upon dissolution and upon payment or adequate discharge of all liabilities and obligations, the assets of the Corporation shall be distributed for one or more exempt purposes within the meaning of §501(c)(3) of the Internal Revenue Code, as amended, or shall be distributed to a state or the Federal government for a public purpose.
