ARTICLES OF AMENDMENT TO THE ARTICLES OF INCORPORATION OF TAL CONGREGATION BEIT CHAVERIM OF SARASOTA, INC.

1. The following provisions of the Articles of Incorporation of CONGREGATION BEIT CHAVERIM OF SARASOTA, INC., a Florida Not For Profit Corporation, effective with the Secretary of State on, are amended, effective March 15, 2003, as follows:
