ARTICLES OF INCORPORATION
In Compliance with Chapter 617, F.S., (Not for Profit)

ARTICLE VIII

Upon dissolution of the corporation assets shall be distributed for one or more exempt purposes within the meaning of section 501 \odot 3 of the Internal Revenue Code or the corresponding section of any future federal tax code or shall be distributed to the federal government or to a state or local government for a public purpose.

Any such assets not so disposed of shall be disposed by a court of competent Jurisdiction of the county in which the principal office of the corporation is then located exclusively for such purpose or to such organization or organizations as said court shall determine which are organized and operated exclusively for such purposes.
