ARTICLES OF INCORPORATION

GREATER LOVE COMMUNITY INVOLVEMENT, INC.

We, the undersigned subscribers, all being of full age, have associated ourselves together for the purpose of forming a corporation not-for-profit, without capital stock, under the provisions of all applicable State of Florida Statutes. We hereby accept all the rights, privileges, benefits and obligations conferred and imposed by said law, and we do hereby, subscribe, acknowledge and file these Articles of Incorporation.

ARTICLE I

NAME: GREATER LOVE, COMMUNITY INVOLVEMENT, INC.
(FEIN 65-0618971)

ARTICLE II

PURPOSE: To provide assistance to all residents of target areas in improving their standard of life; promote better housing, streets, and other necessities aimed at building better neighborhoods. Formulate an educational system aimed at improving the literacy of affected persons in the community (reading and computer) especially our young people that dropped out of school with inadequate language skills. Provide recreational and learning facilities that enhance a healthy environment for our youngsters aimed at preventing crime, alcohol and drug abuse.

ARTICLE III

TERM OF EXISTENCE: The term of existence of this corporation is perpetual.

ARTICLE IV

OFFICERS AND MANAGEMENT: The officers of this not-for-profit corporation shall be a President, Vice-President, Secretary, Treasurer, and Financial Secretary. Management shall be vested in a board of directors, consisting of at least seven (7) and no more than fifteen (15). Directors shall be chosen from persons within the community that have demonstrated their willingness to serve, and their ability to make positive change.

ARTICLE VIII

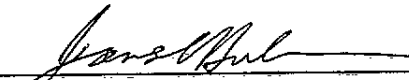

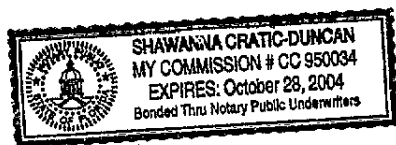
