# ARTICLES OF INCORPORATION

OF

ENDURE COMMUNITY DEVELOPMENT CORPORATION TALLALIZED FLORIDA A FLORIDA 'NOT FOR PROFIT' CORPORATION

THE UNDERSIGNED, ACTING AS INCORPORATOR OF A CORPORATION UNDER THE FLORIDA STATUES, ADOPTS THE FOLLOWING ARTICLES OF INCORPORATION;

#### ARTICLE I

THE NAME OF THE CORPORATION IS ENDURE COMMUNITY DEVELOPMENT CORPORATION". THE PRINCIPLE OFFICE OF THE CORPORATION IS LOCATED AT 1735 N. W. 121 St., MIAMI, FL 33167

#### ARTICLE II

THE PERIOD OF DURATION IS PERPETUAL. THE CORPORATION IS ORGANIZED PURSUANT TO THE NOT FOR PROFIT CORPORATION LAWS OF THE STATE OF FLORIDA. THE QUALIFICATIONS FOR MEMBERS, IF ANY, AND THE MANNER OF THEIR ADMISSION SHALL BE REGULATED BY THE BYLAWS.

#### ARTICLE III

THE PURPOSES FOR WHICH THIS CORPORATION IS FORMED ARE EXCLUSIVELY CHARITABLE, EDUCATIONAL AND SCIENTIFIC AND CONSIST OF THE FOLLOWING;

1. TO RAISE THE ECONOMIC, EDUCATIONAL AND SOCIAL LEVELS OF THE RESIDENTS OF MIAMI-DADE AND BROWARD COUNTIES FLORIDA, INCLUDING MEMBERS OF THE MINORITY COMMUNITY, WHO ARE SUBSTANTIALLY UNEMPLOYED, UNDEREMPLOYED, OR WHOSE INCOME IS BELOW FEDERAL POVERTY GUIDELINES, TO FOSTER AND PROMOTE COMMUNITY WIDE INTEREST AND CONCERN FOR THE PROBLEMS OF THE SAID RESIDENTS TO THE END THAT (A) EDUCATIONAL AND ECONOMIC OPPORTUNITIES MAY BE EXPANDED; (B) SICKNESS, POVERTY, CRIME, AND ENVIRONMENTAL DEGRADATION MAY BE LESSENED; AND (C) RACIAL TENSIONS, PREJUDICE, AND DISCRIMINATION, ECONOMIC, AND OTHERWISE, MAY BE ELIMINATED.

- 2. TO EXPAND THE OPPORTUNITIES AVAILABLE TO SAID RESIDENTS AND GROUPS TO OWN, MANAGE, AND OPERATE BUSINESS ENTERPRISES IN ECONOMICALLY DEPRESSED AREAS. TO ASSIST SAID RESIDENTS AND GROUPS IN DEVELOPING ENTREPRENEURIAL AND MANAGEMENT SKILLS NECESSARY FOR THE SUCESSFUL OPERATION OF BUSINESS ENTERPRISES, AND TO ASSIST SAID RESIDENTS AND GROUPS ON OBTAINING FINANCIAL SUPPORT FROM OTHER SOURCES.
- 3. TO EXPAND OPPORTUNITIES AVAILABLE TO SAID RESIDENTS AND GROUPS TO OBTAIN ADEQUATE LOW-COST HOUSING ACCOMADATIONS BY CONSTRUCTING, REHABILITATING, AND PROVIDING DECENT, SAFE AND SANITARY HOUSING IN MIAMI-DADE & BROWARD COUNTIES FOR PERSONS AND FAMILIES OF LOW-INCOME WHO OTHERWISE WOULD NOT BE ABLE TO FIND OR AFFORD A SUITABLEPLACE TO LIVE. IT IS THE PURPOSE OF THE CORPORATION THEREBY TO RELIEVE THE POOR, DISTRESSED, UNDERPRIVILEDGED AND INDIGENT BY ENABLING THEM TO SECURE THE BASIC HUMAN NEEDS OF DECENT SHELTER AND THUS LESSEN THE BURDENS OF GOVERNMENT AND PROMOTE SOCIAL WELFARE. TO PROVIDE SUCH HOUSING THROUGH REHABILITATION OF EXISTING SUBSTANDARD BUILDINGS AND CONSTRUCTION OF NEW FACILITIES IN THE PLACE OF BLIGHTED STRRUCTURES OR BLIGHTED VACANT SITES FOR THE PURPOSE OF COMBATING THE DETERIORATION OF THE COMMUNITY AND CONTRIBUTING TO ITS PHYSICAL IMPROVEMENT.
- 4. TO AID, SUPPORT, ASSIST BY GIFTS, CONTRIBUTIONS, OR OTHERWISE, OTHER CORPORATION, COMMUNITY CHESTS, FUNDS AND FOUNDATIONS ORGANIZED AND OPERATED EXCLUSIVELY FOR THE CHARITABLE, EDUCATIONAL OR SCIENTIFIC PURPOSES. NO PART OF THE NET EARNINGS WHICH INSURES TO THE BENEFIT OF ANY PRIVATE SHAREHOLDER OR INDIVIDUAL, AND NO SUBSTANTIAL PART OF THE ACTIVITIES OF WHICH IS CARRYING ON PROPAGANDA, OR OTHERWISE ATTEMPTING TO INFLUENCE LEGISLATION.
- 5. TO DO ANY AND ALL LAWFUL ACTIVITIES WHICH MAYBE NECESSARY, USEFUL, OR DESIRABLE FOR THE FURTHERANCE, ACCOMPLISHMENT, FOSTERING, OR ATTAINING OF THE FOREGOING PURPOSES. EITHER DIRECTLY OR INDIRECTLY, AND EITHER ALONE OR IN CONJUNCTION OR COOPERATION WITH OTHERS. WHETHER SUCH OTHERS BE PERSONS OR ORGANIZATIONS OF ANY KIND OR NATURE, SUCH AS CORPORATIONS, FIRMS, ASSOCIATION, TRUSTS, INSTITUTION, FOUNDATIONS, OR GOVERNMENTAL BUREAUS, DEPARTMENTS OF AGENCIES.

6. ALL OF THE FOREGONG PURPOSE SHALL BE EXERCISED EXCLUSIVELY CHARITABLE AND EDUCATIONAL PURPOSES IN SUCH A MANNER THAT THE CORPORATION WILL QUALIFY AS AN EXEMPT ORGANIZATION UNDER SECTION 501 (c) (3) OF THE INTERNAL REVENUE CODE OF 1986B OF THE CORRESPONDING PROVISION OF ANY FUTURE UNITED STATES INTERNAL REVENUE LAW.

#### **ARTICLE IV**

NOT WITHSTANDING ANY OTHER PROVISION OF THESE ARTICLES, THIS ORGANIZATION SHALL NOT CARRY ON ANY OTHER ACTIVITIES NOT PERMITTED TO BE CARRIED ON BY AN ORGANIZATION EXEMPT FROM FEDERAL AND STATE INCOME TAX UNDER SECTION 501 ( c ) (3) OF THE INTERNAL REVENUE CODE OF 1986 OR THE CORRESPONDING PROVISION OF ANY FUTURE UNITED STATES INTERNAL REVENUE LAW.

#### ARTICLE V

#### **ARTICLE VI**

THE METHOD OF ELECTION OF THE BOARD OF DIRECTORS SHALL BE STATED IN THE BYLAWS.

#### **ARTICLE VII**

THE CORPORATION IS ORGANIZED EXCLUSIVELY FOR CHARITABLE AND EDUCATIONAL PURPOSES. THE CORPORATION IS ORGANIZED NOR SHALL IT BE OPERATED FOR THE PRIMARY PURPOSE OF GENERATING PECUNIARY GAIN OR PROFIT. THE CORPORATION SHALL NOT DISTRIBUTE ANY GAINS, PROFITS OR DIVIDENDS TO THE DIRECTORS, OFFICERS, OR MEMBERS THEREOF, OR TO ANY INDIVIDUAL, EXCEPT AS REASONABLE COMPENSATION FOR SERVICES ACTUALLY PERFORMED IN CARRYING OUT THE CORPORATION'S CHARITABLE AND EDUCATIONAL PURPOSES. SHALL NOT MAKE ANY INVESTMENTS INSUCH MANNER AS TO SUBJECT IT TO TAX UNDER SECTION 4944 OF THE INTERNAL REVENUE CODE. AND SHALL NOT MAKE ANY TAXABLE PENDITURES AS DEFINED IN SECTION 4945 (d) OF THE INTERNAL REVENUE CODE.
