

ARTICLES OF INCORPORATION OF

National Association of Ministers Inc, U.S.A.

The undersigned incorporator, for the purpose of forming a corporation under the Florida Not-for-Profit Corporation Act, hereby adopt(s) the following Articles of Incorporation:

ARTICLE I. NAME

The name of the corporation shall be:
National Association of Ministers Inc, U.S.A.
A Florida Not-for-Profit Corporation

ARTICLE II. PRINCIPAL OFFICE

4402 W. Osborne Ave. Tampa, FL. 33614

ARTICLE III. PURPOSE(S)

This corporation has no affiliation with any evangelical or general assembly in the U.S.A. or anywhere, but the corporation's ministry is based on the Biblical Prophetic Apostolic Doctrines Foundation, and the Board of Directors, are all ordained ministers with the same biblical faith. This ministry will function under all article for Not-for-Profit article as IRS section 501(c)(3)

We will serve as a form of communication between the church and the government; not as legal representatives in any dispute or legal action. We will address the church's needs and also the community's social needs, (these needs are based upon biblical principles), and communicate these needs to the government either verbally or in written form.

ARTICLE IV. MANNER OF ELECTION OF DIRECTORS

The President will elect the initial Board of Directors. The director will serve one year as a director of the corporation, or as from time to time may be needed. Future board members will be selected as provided in the corporation's Constitution and By-Laws, as from time to time in existence. The Corporation is organized under a non-stock basis.


ARTICLE IX NET EARNINGS
