Article I

The name of this corporation shall be *Dixie Hollins High School Alumni Association, Inc.*

Article III

The many purposes of this corporation include but are not limited to the following:

To create an organization that will allow current and future students of Dixie Hollins High School to benefit from the wisdom and generosity of the alumni that preceded them.

To assist in improving the public image of Dixie Hollins High School in our community as recommended by SACS and the School Improvement Plan, thereby improving the self-esteem of the students and faculty of the school.

To assist school groups such as the PTSA with their membership drives and in their efforts to promote parent and community involvement with the school.

To encourage alumni participation in events that benefit the school; to revitalize Homecoming Week at Dixie Hollins High School.

To assist the school's volunteer coordinator in finding tutors and mentors for struggling students at Dixie Hollins High School.

To provide financial assistance with various projects and activities that benefit the students of Dixie Hollins High School.

To create an awareness among current and future students that they are part of a continuing legacy of which they can and should be proud, and to provide a multiculturally diverse group of positive, successful alumni role models with whom they may identify.

To create a database of alumni and faculty names, addresses, phone numbers, and e-mail addresses that will assist in the organization of class reunions and other alumni activities, and also to facilitate communications among alumni.

To preserve and pass on the history of our school to current and future students.

To actively encourage and provide assistance to various class reunion groups in their efforts to organize reunions and other social activities.

To establish and maintain the Dixie Hollins Athletic Hall of Fame to recognize and honor past, present, and future student athletes.

Article IV

The President and Chief Executive Officer of the Dixie Hollins Alumni Association, Inc. shall be Sheryl K. Brock and she shall serve until
