ARTICLES OF INCORPORATION

In Compliance with Chapter 617, F.S., (Not for Profit)

I The name of the Incorporation shall be CCAW of Tarpon Springs, Inc.

II The principal place of business and mailing address will be: 134 N. Spring Blvd.

Tarpon Springs, Florida 34689

III The purposes of the corporation for which it is organized is to work for and promote cleaning up and the maintaining of clean air and water in and about the vicinity of Pinellas and Pasco Counties, Florida and such other parts of the State as they may from time to time determine; in so doing to cooperate with all other persons and organizations whose aim and purpose is the same, including State and Federal agencies; to patrol and report any problems of pollution of the air and the water, that they may from time to time find, and in inspecting and investigating air and water pollution they will from time to time take samples of water to be submitted to agencies for analysis, and report all of they findings to the proper State and Federal Officials, and any Municipal or Local Officials who may be working for and interested in the same aims and purposes of the members of this Corporation; that in addition they may from time to time take such action as they may deem necessary to attempt to carry out the purposes of this Corporation, whether by engaging in litigation, reports to other agencies, acting as witnesses, and any other way that they may be of assistance in bringing about cleaner air and water in the vicinity of Pinellas County, Pasco County, Florida and the State of Florida.

IV That the affairs of the Corporation shall be managed by a Board of Directors who shall be elected annually and by a President, Vice-President, Secretary and Treasurer of said Corporation who will also be members of the Board of Directors. Initially, the Board of Directors will be appointed by the incorporators.
