The undersigned, acting as incorporators of a Florida NOT FOR PROFIT corporation, adopts the following Articles of Incorporation:

ARTICLE I

The name of the NOT FOR PROFIT Corporation shall be DOUG REED MINISTRIES INC.

ARTICLE II

The address of the principle office and mailing address of DOUG REED MINISTRIES INC

ARTICLE III

The purposes for which the corporation is organized are:

EVANGELISTIC MINISTRY, FOCUS ON YOUTH MINISTRY AND MOTIVATIONAL SPEAKING AND TEACHING. IN SCHOOLS, CHURCHES IN THE UNITED STATES AND OTHER NATIONS. TO ENGAGE IN ANY ACTIVITY OR BUSINESS PERMITTED UNDER THE LAWS OF THE UNITED STATES OF AMERICA AND ALL STATES.




