

The undersigned, all of whom are citizens of the United States, desiring to form a corporation not-for-profit, under F.S. 617, do hereby certify:

FIRST: The name of said corporation shall be
Grace Community Baptist Church of Gilchrist County, Inc..

SECOND: The place where the principal office of the corporation is to be located is:
89 N.E. 112th Place, Branford, Florida 32008

THIRD: The purpose or purposes for which the corporation is formed are religious, charitable and educational, including:

- (A) Receiving, holding and disbursing gifts, bequests, and funds arising from all sources.
- (B) Acquiring, owning and maintaining real estate, buildings, and other property, real or personal, incidental, necessary, or proper to carry out said objects.
- (C) Doing any and all things necessary or incidental to the accomplishment of such purposes.
