The undersigned incorporator, for the purpose of forming a not-for-profit corporation in accordance with chapter 617, Florida Statutes, hereby adopts the following Articles of Incorporation:

ARTICLE I

The name of the corporation shall be:

Bet Shira Early Childhood Center, P.T.A., Inc.

ARTICLE II

The principal place of business and mailing address of this corporation shall be:

7500 S.W. 120 Street Miami, Florida 33156

ARTICLE III

The Bet Shira Early Childhood Center, P.T.A., Inc. is a not-for-profit organization incorporated under the laws of the State of Florida and Section 501 of the current Internal Revenue Code (hereinafter referred to as the "Corporation"). The purpose of the Corporation shall be to provide support for the students of Temple Bet Shira Early Childhood Center, a temple school for children up to the age of kindergarten, and their Parents. The Bet Shira Early Childhood Center P.T.A., Inc shall raise funds to purchase items for the school, which it is otherwise unable to provide.
