## ARTICLES OF INCORPORATION

# SHADY GROVE BAPTIST CHURCH

GRAND RIDGE FLORIDA INC.

(A corporation not for profit)

We, the undersigned, hereby associate together for the purpose of becoming incorporated under the laws of the state of Florida, applicable to corporations not for profit, under the following charter:

#### ARTICLE I

The name of the corporation shall be Shady Grove Baptist Church of
Grand Ridge, Florida, Inc., located in Jackson County, Florida at 1304 Birchwood Rd,
Grand Ridge, FL, 32442

The purpose or purposes for which this corporation is organized shall be that of a religious society and the general nature of the object of the corporation shall be that of the usual Christian Church, namely: To engage in and conduct services for the worship of god, the study of the Holy Scriptures, and the spread of the Gospel of Jesus Christ. Inclusive within these purposes are the following: To preach and teach the gospel of Jesus Christ, to carry on the work of a Missionary Baptist Church, to promote the spiritual welfare of all people and to disseminate the word of God to the people of all nations, to accept donations, contributions and gifts of all kinds of property, whether real, personal or mixed, and to rent, lease, purchase or otherwise acquire, mortgage, sell and convey all kinds of property, whether real, personal or mixed, or any interest or estate therein in this state or in any of the states of the United States, territories or dependencies.

Any person, male or female, who has accepted Jesus Christ as his or her Savior shall be eligible to become a member of this corporation, or as shall be admitted under the constitution and bylaws of this corporation.

The term for which this corporation is to exist is perpetual.

- 2. To establish and maintain missions and branch churches in Jackson County or elsewhere.
- 3. The members shall have the power and authority to license and ordain persons to the ministry of the Gospel of the Lord Jesus Christ, and authorize them to perform the marriage ceremony.

#### **ARTICLE XIII**

This corporation, not for profit, is formed pursuant to the provisions of Chapter 617, Florida Statutes, 1963.
