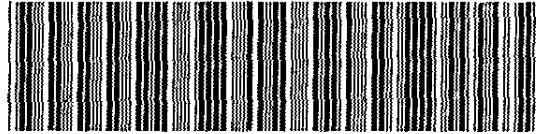


A copy of a standard Transmittal Letter related to the following requested amendments:


Amend ARTICLE 1(name) to: Lighthouse and Historic Building Preservation Society Inc.




