ARTICLES OF INCORPORATION
Of
Ezekiel House, Inc.
(A Corporation Not For Profit)

The undersigned incorporator, for the purposes of forming a corporation under the Florida Business Corporation Act, hereby adopts the following Articles of Incorporation.

ARTICLE I: NAME

The name of the Corporation shall be: **Ezekiel House, Inc.** (a corporation not for profit).

ARTICLE II: PRINCIPAL PLACE OF BUSINESS

The principal place of business of this corporation shall be: **622 - 4th Ave. N., Safety Harbor, Florida 34695.**

ARTICLE III: PURPOSES

The purpose for which this corporation not for profit is organized is to provide counseling and healing prayer services to individuals and families.

ARTICLE IV: OFFICERS AND DIRECTORS

The affairs of the corporation shall be managed by a President, Secretary/Treasurer and a Board of Directors. The officers shall be elected for a term of one (1) year as provided in the By-Laws. The numbers and method of election of the Board of Directors shall be fixed by the By-Laws, but in no event shall said By-Laws fix the number at less than three (3) members of the corporation.


