# ARTICLES OF INCORPORATION CHARIOTS COMMUNITY ENTERPRISE INC.

1. **ARTICLE I – Name of Corporation**

The name of this Corporation shall be Chariots Community Enterprise Inc.

2. **ARTICLE II - Principal Office**

The principal office of the Corporation shall be 3540 SW 3<sup>rd</sup> Street, Fort Lauderdale, Florida 33312 County of Broward, and any other such office or place that the Board of Directors may deem from time to time as per space and facilities needed.

3. **ARTICLE III - Statement of Purpose**

The purpose of the organization is to assist youth and adults who have been subjected to abuse, neglect, molestation, drug addiction or any other ordeal, which results in them needing emotional and or spiritual encouragement through professional services.

To assist adults who are dealing with mental disabilities with services, resource and or employable training and placement. To provide shelter, educational and employable skills training for both youth and adults, individual and group counseling, entrepreneur training, self-esteem workshop, childcare services and other related services, referrals and resources as per clients needs.

To develop and implement innovative approaches to stimulate economic development. To enhance Community development through rehabilitation of existing substandard buildings and construction of new facilities in the place of blighted structures of blighted vacant sites for the purpose of combating the deterioration of the community, contributing to its physical improvement and provide a residence for disadvantaged youth and teenage mothers and their children who become homeless and in need of shelter and love.

To assist in the process of improving the lives, living conditions for each participating client to become self-sufficient.

4. **ARTICLE IV –Appointment of Directors**

The manner in which the Directors are elected or appointed is: For the first fiscal year the board members will be elected by the choice of the Founder/Chief Executive Officer, and a general vote by the appointed board members will decide thereafter.
