

**ARTICLES of INCORPORATION**

**ARTICLE ONE:**

The name of the corporation is **CHRIST REGIONAL CRUSADES, INC.**  
The address for initial registered office is 6100 West Fairfield Drive, Suite B,  
Pensacola, Florida 32506. The corporation is organized pursuant to the  
Florida, Nonprofit Corporation Code.

**ARTICLE TWO:**

This **Religious Corporation** is a person authorized to transact business.  
**No** one may have it's name or same name. It can sue, borrow, file bankruptcy  
and more. This corporation is a nonprofit religious benefit corporation and is  
not organized for the private gain of any person. The corporation is organized  
under **GOD in which we trust** in accordance to the 1<sup>st</sup> Amendment of the  
United States Constitution and **GOD Divine Status (1 Corinthians 12:28)**.  
This *Religious Benefit Corporation is part of the Church, which is the body  
of our Lord and Savior Jesus Christ to promote religious activities.*  
This corporation is tax exempt and can receive tax-deductible contribution as  
outlined in **IRS Publication 557 and Application 1023**.  
This corporation is not required to file annually, tax returns for church or  
religious related business. This corporation shall establish and carry out  
business related to, but, not limited to: the Bylaws; Standard Operational  
Procedures, Religious Creed; Divine and other related religious activities.

**Article Three:**

The duration of this corporation shall be perpetual;  
no stock issued; no members.

**Article Four:**

The registered office of the corporation is:  
6100 West Fairfield Drive, Suite B, Pensacola, Florida 32506.

The name and address of the registered agent of the corporation shall be:

**Article Five:**

This corporation is organized and operated exclusively for Religious, Educational and Charitable purposes within the meaning of Section 501(c)(3) of the Internal Revenue Code. Notwithstanding any other provision of these Articles, the corporation shall not carry on any other activities not permitted to carry on by a corporation exempt from federal income tax under Section 501(c)(3) of the Internal Revenue Code..

**Article Six:**

The property of this corporation is irrevocably dedicated to Religious, Educational and Charitable purposes and no part of the net income or assets of the organization shall ever inure to the benefit of any director, officer or member thereof or the benefit of any private person.

**Article Seven:**

Upon dissolution of the corporation, assets shall be distributed for one or more exempt purposes within the meaning of Section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future tax code, or shall be distributed to the federal government, or to a state or local government, for a public purpose. Any such assets not so disposed of by a Court of Competent Jurisdiction of the county in which the principal office of the corporation is then located, exclusively for such purposes or to such organization or organizations, as said Court shall determine, which are organized and operated exclusively for such purposes.

**Article Eight:**

The Directors are elected in accordance with the Bylaws.


The number of Directors shall be three (3). A Director must be 18 years of age.






