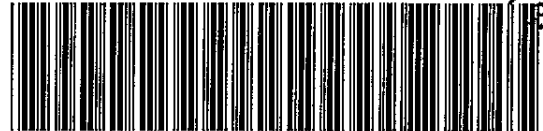

Resolution and Organizational Development

A meeting was held on Wednesday, December 11, 2002 at approximately 5:00p.m. at Dunamis Full Gospel Fellowship Ministries, 3520 South Orange Ave. Orlando, Florida 32806.

The topic of discussion was to finalize the merge between Dunamis Full Gospel Fellowship Ministries and Eternal Life Bible Church. Those present at the meeting were the following: Rev. Vincent B. Holmes, Rev. Lorna Denise Holmes, Pastors and founders of Dunamis Full Gospel Fellowship Ministries, Rev. Willie Green, Pastor and founders of Eternal Life Bible Church, Minister Keith Martin, Youth Minister of Eternal Life Bible Church.

Resolution: It was agreed upon by the ordained clergy that Dunamis Full Gospel Fellowship Ministries and Eternal Life Bible Church become one body. Thus changing the name of the ministry corporation to: **Dunamis Eternal Full Gospel Fellowship Ministries, INC.** ^{VS}

It was further agreed upon that Rev. Willie Green forward the revised Articles of ~~Merge~~ reflecting the merging of the churches along with the name change to the Florida Department of State.

In conclusion to the resolution the appointment of officers assigned to govern the church according to the bi-laws of the D.E.F.G.F. be assigned Sunday, January 5, 2003.

Responsible for overseeing and development of Educational Programs, collaborates with the Sr. Pastor in activities of church development.

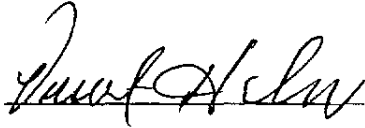
Assistant Pastor and Outreach Coordinator ~ Rev. Lorna Denise Holmes

Responsible for Youth Activities, works with Choirs, Church School and Youth Outreach, collaborates with all ministers.

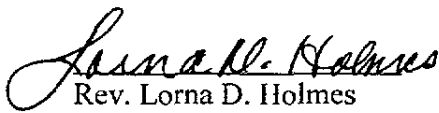
