The undersigned incorporator for the purposes of forming a Florida not-for-profit-corporation, hereby adopt the following Articles of Incorporation:

ARTICLE I - NAME

The name of the corporation, hereinafter referred to as the "Corporation" is:

ARTICLE II - PLACE OF BUSINESS

The specific purpose for which this organization is organized is:

ARTICLE IV - ELECTION OF DIRECTORS

ARTICLE V – ASSETS AND EARNINGS

No part of the assets or net earnings of the Corporation shall inure to the benefit of any member, trustee, officer of the Corporation, or any private individual, except that reasonable compensation may be paid for services rendered to or for the Corporation affecting one or more of its purposes, and no member, trustee, officer of the Corporation, or any private individual shall be entitled to share in the distribution of any of the corporate assets on dissolution of the Corporation.

ARTICLE VI – DISSOLUTION

Upon the dissolution of the Corporation or the winding up of its affairs, the assets of the Corporation shall be distributed exclusively to one or more charitable, religious, scientific, testing for public safety, literary, or educational organizations which would then qualify under the provisions of Section 501(c)(3) of the Internal Revenue Code and its Regulations as they now exist or as they may be hereafter amended, or to the federal government, or to a state or local government, for a public purpose.
