ARTICLES OF INCORPORATION

The undersigned persons, acting as incorporators of a corporation not for profit under the Florida Not For Profit Corporation Act, as set forth in Chapter L17 of the Florida Statutes, adopt the following Articles of Incorporation for the corporation:

## Article I

The name of the corporation is JAMAICA CHRISTIAN SERVICES, INC.

## Article II

The corporation shall have perpetual duration.

# Article III

The corporation is a not for profit corporation. The purposes for which the corporation is organized are:

(a) The specific and primary purposes for which this corporation is formed are to operate for the advancement of religion, charity and education and for other charitable purposes, by the distribution of its funds for those purposes, and particularly to educate and train persons desiring to become ministers and trained leaders of the Word of God and the teachings of Jesus Christ or who desire to enter into the field of Christian education and to serve as a resource for the churches in Jamaica. Additionally, Jamaica Christian Services, Inc. exists to provide general support of evangelistic and educational work in Jamaica.

- (b) The general purposes for which this corporation is formed are to operate exclusively for religious, charitable and educational purposes which will qualify it as an exempt organization under Section 501(c)(3) of the Internal Revenue Code of 1986 or corresponding provisions of any subsequent federal tax laws, including, for those purposes, the making of distributions to organizations which qualify as tax-exempt organizations under that Code.
- (c) This corporation shall not, as a substantial part of its activities, carry on propaganda or otherwise attempt to influence legislation, nor shall it participate or intervene (by publication or distribution of any statements or otherwise) in any political campaign on behalf of any candidate for public office.

Article IV

- (a) Directors as Membership. The sole class of members of this corporation shall be its directors.
- (b) Rights and Liabilities of Members. The members of this corporation shall have no right; title; or interest in its income; property; or assets; nor shall any portion of its income; property; or assets be distributed to any member on the dissolution or winding up of this corporation. Members of this corporation shall not be personally liable for the debts; liabilities; or obligations of the corporation; and shall not be subject to any assessments.

# Article V

The street address of the principal office and initial registered office of the corporation is 1011 Bill Beck Blvd, Kissimmee, FL 34744. The name of its initial registered agent at that address is James Book.

#### Article\_VI

The powers of this corporation shall be exercised its property controlled, and its affairs conducted by a board of directors. The number of directors of the corporation shall be not less than three (3) or more than fifteen (15); provided, however, that number may be increased by a bylaw duly adopted pursuant to the bylaws of this corporation.

The directors named here as the first board of directors shall hold office until the first meeting of members, to be held on , 2002 at 9:30 a.m. at 1011 Bill Beck Blvd, Kissimmee, FL 34744, at which time an election of directors shall be held.

Directors elected at the first annual meeting, and at all subsequent times, shall serve for a term of two (2) years until the second annual meeting of members following the election of directors and until the qualification of the successors in office. Annual meetings shall be held on the 25th day of May of each year at the principal office of the corporation, or at any other place or places designated by the board of directors by resolution.

Any action required or permitted to be taken by the board of directors under any provision of law may be taken without a meeting if all the members of the board individually or collectively consent in writing to the action. Written consent or consents shall be filed with the minutes of the proceedings of the board and any action by written consent shall have the same force and effect as if taken by unanimous vote of the directors. Any certificate or other document filed under any provision of law that relates to action taken in this manner shall state that the action was taken by unanimous written consent of the board of directors without a meeting and that the articles of incorporation and bylaws of this corporation authorize the directors to act in this manner. This statement shall be prima facie evidence of the directors authority.

### Article IX

Subject to the limitations contained in the bylaws and any limitations set forth in the Not For Profit Corporation Act of Florida described above, concerning corporate action that must be authorized or approved by the members of the corporation, the bylaws of this corporation may be made, altered, rescinded, added to or new bylaws may be adopted, either by a resolution of the board of directors or by following the procedure set forth in the bylaws.
