**ARTICLES OF INCORPORATION
OF
BANGLADESH CULTURAL ASSOCIATES OF FLORIDA, INC
A FLORIDA NONPROFIT CORPORATION**

The undersigned incorporator hereby forms a corporation under chapter 617 of the laws of the State of Florida.

ARTICLE I. CORPORATE NAME & ADDRESS

The name of the Corporation shall be:

BANGLADESH CULTURAL ASSOCIATES OF FLORIDA, INC

The address of the principal office in the State of Florida is 1489 N. Military Trail # 115 B, West Palm Beach, FL 33409, County of Palm Beach, and the mailing address of the corporation is 8253 White Rock Circle, Boynton Beach, FL 33436.

ARTICLE II. PURPOSES.

This corporation is a not-for-profit corporation organized under chapter 617, Florida Statutes. It is not organized for the private gain of any person. The members shall not have a vested interest in the corporation's assets and upon dissolution the corporation must distribute all of its assets to one or more section 501 (c)(3) organizations or governmental entities.

The nature of the corporation or purpose is to promote the general public's awareness of the culture, history and lifestyle of Bangladesh.

Additionally, the corporation will seek to educate Bangladeshi children residing in Florida about their own culture.

However, that the corporation shall not engage in any action which is not permitted to be carried on by nonprofit corporations under the Internal Revenue Code and that the assets and

net earnings must not inure to the benefit of any member, officer, or director; but the Corporation shall be authorized and empowered to pay reasonable compensation to these people for services rendered, and to make payments and distributions in furtherance of its stated purposes.

ARTICLE III. NON STOCK BASIS.

The Corporation is organized (and shall be operated) on a non stock basis within the meaning of the Florida Not For Profit Corporation Act, and shall not have the power to issue shares of any type or class of stock, but may issue membership certificates if so provided in the bylaws.

ARTICLE IV. REGISTERED AGENT NAME & ADDRESS.
