## **ARTICLES OF INCORPORATION**

### **FOR**

#### **IGLESIA PENTECOSTAL LA FE NACIDA DE NUEVO, INC. (New Born Faith, Pentecostal Church, Inc.) (NOT FOR PROFIT)**

We, the undersigned persons of the State of Florida, all of whom are of legal age, each being competent to contract, hereby form ourselves and our successors into a corporation not for profit under the Laws of State of Florida, and hereby adopt the following Articles of Incorporation:

#### **ARTICLE I – NAME**

The name of this corporation shall be Iglesia Pentecostal La Fe Nacida de Nuevo, Inc.

#### **ARTICLE II – PRINCIPAL PLACE OF BUSINESS AND MAILING ADDRESS**
