ARTICLES OF INCORPORATION  
OF  
THE INTERNATIONAL PUBLIC ECOLOGICAL  
MOVEMENT-THE LIVING PLANET, INC.

I, the undersigned acting as incorporator of a Corporation pursuant to Chapter 617, Florida Statutes, adopts the following Articles of Incorporation of such corporation and associates together for the purpose of becoming a corporation, not for profit, providing for the formation, liability, rights, privileges and immunities of corporation not for profit.

ARTICLE I

The name of the corporation shall be THE INTERNATIONAL PUBLIC ECOLOGICAL MOVEMENT-THE LIVING PLANET, INC. The Principal place of business and mailing address of this corporation shall be:

ARTICLE II

The existence of this corporation shall be perpetual unless dissolved according to law.

ARTICLE III

The purpose for which this corporation is organized is the collection, summarizing and analysis of the information about ecological situation in the regions of the Russian Federation and

other countries of the world; ecological monitoring, ecological audit and creation of an easily understood information system for the evaluation of the situation of the environment; and, participation in the development of international contacts in the sphere of the ecological safety, preservation of the environment, rational use of the natural resources, and the exchange of the experience with non-government ecological organizations from other countries.

#### ARTICLE IV

The qualification of members and the manner of their admission to this nonprofit corporation is to be provided for in the Bylaws, and shall be on any applicant who desires to promote ecological awareness of the regions of the Russian Federation, in South Florida.

In the event of dissolution, the residual assets of the organization will be turned over to one or more organizations which themselves are exempted organizations described in Section 501(c)(3) and 170(c)(2) of the Internal Revenue Code or corresponding sections of any prior or further law, or the Federal State, or Local Government for exclusive public purpose.

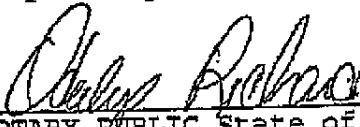

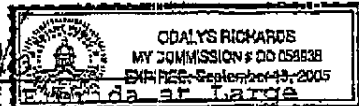

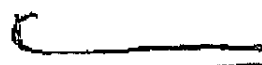
