

Pursuant to the provisions of Section 617.1006 of the Florida Statutes, the undersigned corporation adopts the following articles of amendment to its articles of incorporation:

1. The name of the corporation is SOUTHWOOD ACRES HOMEOWNERS ASSOCIATION, INC.

2. No members are entitled to vote on the amendment. The following amendments of the articles of incorporation were unanimously adopted by the Board of Directors of the corporation on September 3, 2002, in the manner prescribed by law:

ARTICLE III - PURPOSE

A. To fix and make assessments and collect the assessments.

G. To make, amend, impose, and enforce reasonable rules and regulations of use of the common areas, entrance areas and association property.

J. To do and perform any obligations imposed upon the association by the declaration or by any permit or authorization from any unit of local, regional, state, or the federal government and to enforce the provisions of these articles, the bylaws and the declaration.


ARTICLE IV - POWERS


E. To maintain, repair, replace and operate property owned, leased or managed by it, purchase insurance thereon, and to make

and adopt reasonable regulations respecting the use and appearance of the entrances and other property owned or controlled by the corporation, and to enforce the provisions of these articles of incorporation and any bylaws or regulations adopted pursuant hereto.


