**Articles of Incorporation
of
Students Teaching About Holocaust Remembrance, Inc.
(Not For Profit)**

The undersigned, acting as incorporator, hereby adopts these Articles of Incorporation and forms a Not For Profit corporation in compliance with the laws of the State of Florida (Chapter 617, F.S.) as follows:

ARTICLE I- NAME

The name of the Corporation shall be: STUDENTS TEACHING ABOUT
HOLOCAUST REMEMBRANCE, INC.

ARTICLE II- PRINCIPAL OFFICE

ARTICLE III- PURPOSE

The purpose for which the Corporation is organized is:

- A. To educate students in primary and secondary schooling concerning the historical significance of the Holocaust.
- B. To promote remembrance of the Holocaust.
- C. To provide recognition to survivors and/or supporters of the Holocaust's cause.
- D. To use education of the Holocaust a tool to promote religious and ethnic unity.
- E. To unite to community for endowing awareness of the Holocaust.

- G. To take any actions necessary for carrying out the purposes stated above for Students Teaching About Holocaust Remembrance, Inc.
