**ARTICLE I. NAME**

The name of this corporation shall be:

GOSPEL XPRESS MINISTRIES OF ORLANDO, INC.

**ARTICLE II. ADDRESS**

The initial street address of the principal office of the corporation in the State of Florida shall be 3712 Ranchwood Rd, Orlando, Florida 32808. The Board of Directors may from time to time move the principal office to any other place or places as may be designated by the Board of Directors.

**ARTICLE IV. REGISTERED OFFICE AND REGISTERED AGENT**

## **ARTICLE V.      PURPOSE**

The purpose of this corporation shall be to operate exclusively for religious, Charitable, scientific, and education purposes and in furtherance of such goals is authorized to do any or all activities which it is empowered to do under Chapter 617 and 607, as appropriate; provided, however, that nothing herein shall be construed as allowing any activities which would jeopardize the corporation's tax-exempt status or otherwise be inconsistent with its classification as an organization described in Section 501© (3) of the Internal Revenue Code or 1986 as amended from time to time or any equivalent section of the Internal Revenue Code in effect at any time. Briefly outlined, the corporation shall carry among other religious activities the following operations:

1. Promotion of the Gospel of Jesus Christ through radio, television, audio and video ministries.
2. To minister the word of god in the winter park area teaching and exhortation holy and righteous living.
3. To have build up to worldwide evangelistic trust with a focus on salvation and healing.
4. To have homes or apartment that will stand for righteousness and to teach god's word on a regular basic for parents as well as children this place would have a basketball court gym, party house, and a workout room to stay fit.
5. Daycare that teach Jesus and show love pray for the sickness and teach to pray.
6. To draw people back unto the lord Jesus Christ of Nazareth again with their heart.

**ARTICLE VI. DIRECTORS**

This corporation shall have a governing Board of Directors to be headed by an Ordained Minister of the Gospel. The initial number shall be five (5) directors. The number of directors may be increased or diminished from time to time by the By-Laws adopted by the members of GOSPEL XPRESS MINISTRIES OF ORLANDO, INC.


**ARTICLE VII. PROHIBITED ACTIVITIES**

**ARTICLE VIII. DISTRIBUTION UPON DISSOLUTION**

Upon the dissolution of the corporation, assets shall be distributed for one or more exempt purposes within the meaning of Section 501 © (3) of the Internal Revenue Code, or the corresponding section of any future federal tax code, or shall be distributed to federal government, or to a state or local government, for public purposes. Any such assets not so disposed of shall be disposed of by a court of competent jurisdiction in the county in which the principal office of the corporation is then located.


