Article I

The name of this corporation is Caldwell Foundation In Christ Community Life Outreach Ministry, Inc.

Article II

The name and address in the State of Florida of this corporation's initial agent for service of process is: Elder LeRoy J. Caldwell Sr., 10 Apache Trail, Pensacola Florida 32506.

The corporations principal and Registered Agent address are the same.

Article III

This corporation is a religious corporation and is not organized for the private gain of any person. It is organized under the Nonprofit Religious Corporation Law of Florida exclusively for the religious purposes as a local outreach ministry. The ministry may ordain ministers of the Gospel. The duration of the corporation is perpetual.

- A. The specific purpose of this corporation is to further the Gospel of the Lord Jesus Christ, and to engage in any lawful act or activity for which corporations may be organized under the Nonprofit Religious Corporation Law of Florida.
- B. The corporation shall not have capital stock.
- C. The corporation has membership as specified in the Bylaws of the corporation, or:

[The corporation elects to have no members. Any action, which would otherwise require a vote of members, shall require only a vote of the members of the Board of Directors, and no meeting or vote of members shall be required for this Corporation, any provision of the Articles of Incorporation of the Corporation of the Bylaws of the corporation to the contrary notwithstanding.]

Article IV

The Directors shall be elected at each annual meeting, or at a special meeting called for the purpose of election Directors, or the Directors may be designated at any time by the unanimous written consent of the Board of Directors. Each Director shall hold office until the next annual meeting and until his/her successor is elected, or until his earlier resignation, removal from office, or death.
